Tree Commission Meeting Minutes Thursday January 13th, 2022 @ 5:00 PM Virtual Meeting - Stoughton, WI

Call to order: Esch called to order @ 5:00 PM

- Communications:
- <u>Approval of minutes from December 9th, 2021 Meeting:</u> Motion by Tangeman, seconded by Mazzone to approve the minutes. Carried 6-0.
- November Forestry Reports: Kemppainen stated:
 - Fall tree trimming was completed in December with the city's contractor. (Tree Wise Men) 180 medium to large trees were trimmed for a total cost of \$16,676. City crews will work on small trees in the same neighborhoods this coming winter.
 - I assisted with snow removal for on storm (2 overnight shifts) in December.
 - I received confirmation of Stoughton's Tree City USA status for 2021.
 - The Tree Commission is working to sponsor an art fair at the public library in celebration of Arbor Day 2022. Kathy Esch (Tree Commission chairperson) has been spearheading the effort.
 - The Riverfront Project plans were reviewed with project designers. I provided input into tree planting for public spaces
 - No residents were notified of code violations for dead/dying/dangerous trees in October.
 Compliance from previous notifications has been mostly good thus far.
- OLD BUSINESS: Update on Arbor Day Art show progress:
- Esch has posters printed and art paper at the Library ready to go. The show will be advertised every two weeks on Facebook and she has been handing out posters and receiving quite a bit of interest. She is still working on making sure the Arbor flags are able to be hung at the PD, Library and Public Works building.
- NEW BUSINESS:Tree Sale
- Kemppainen spoke to Jay Weiss from Cambridge about how he has handled past tree sales and advised that he typically sells them in #5 containers, orders in advance and then sells on a first come, first served basis. Kemppainen also looked into McKay Nursery and found that they do have availability and pricing depends on the species. He thought it would be a good idea to pick 4 to 5 different species. Once these are determined delivery or pick up could be in April. Any potential profit from this sale would go back into the Tree Commission fund.

Motion by Hundt, seconded by Mazzone to approve Tree Sale for fundraiser for Tree Commission Spring of 2022. Motion carried 6-0

- Winter tree trimming was begun in January with the city's contractor (Tree Wise Men).
 345 medium to large trees were trimmed for a total cost of \$19,143. City crews will work on small trees in the same neighborhoods in February.
- I assisted with snow removal for multiple storm events in January.
- The Tree Commission is sponsoring an art fair at the public library in celebration of Arbor Day 2022. Kathy Esch (Tree Commission chairperson) has been spearheading the effort.
- I will be speaking on Urban Wood Utilization at the upcoming Wisconsin Arborist Association conference in Green Bay on February 22.
- Spring tree planting planning has begun. I ordered 25 trees for the gravel bed at Public Works for infill trees.
- The Riverfront Project plans were modified and reviewed again with project designers. I
 provided input into tree planting for public spaces.
- No residents were notified of code violations for dead/dying/dangerous trees in October.
 Compliance from previous notifications has been mostly good thus far.
