- 1. The meeting was called to order by President Verden--10:02 am.
- 2. Motion to approve November 19, 2019 Minutes by Lawrence, second by Reeves—10:03 am.
- 3. Director's Report—10:05 am.
 - a. The beginning of the Opera House booking season is underway.
 - b. We're getting several requests by performers for Catfish River Music Festival.
 - c. There have been many projects underway such as a better organized filing system and estimates for the first floor space.
 - d. This Friday's Mandolin Orange show is sold-out.
 - e. We've received mentions in the Isthmus as well as their Picks section.
 - f. Dead Horses will be playing on February 22, the Opera House's 119-year anniversary.
 - g. The Arts Council has set Sept. 26th as 2020 Stoughton Art Walk date and has started planning.
 - i. Sept. 26th is also the date being held for an Agnes Obel performance.
 - h. March will be busy with 3 or 4 shows a week.
 - i. The replacement glass for the kiosk arrived. We will need to bring in help for installation.
 - j. We had a cocoa bar in the gift shop in December that went over well. People noticed when refreshments weren't available.
 - k. The February fundraiser has been moved to Friday, April 3rd and will be focused on first floor improvements.
 - i. We will be working with SOHFA and creating tiered ticket packages.
- 4. Financial Report—10:25 am.
 - a. Rhiannon Giddens and Steve Earle gave us a nice boast in the first half of the season.
 - b. We lost money with Kaki King and Lee Ann Womack.
 - c. We planned a higher income in the first half of the season than we got, but we made up for some of the deficit with new credit card fees.
 - d. We don't have the final budget yet; it still needs some updated numbers.
 - e. We are looking for more ways to capture additional revenue when people walk through the door.
- 5. SOHFA Report—10:45 am.
 - a. We have one estimate for work on the first floor at \$38,000, and have a second estimate in progress.
 - b. Catfish is on the horizon for July 3-5.

- c. Brandi has been working on a fundraising strategy:
 - i. Phase 1—Get the floors, walls, and ceiling work completed to create a clean slate.
 - ii. Phase 2—Fundraising by connecting with family foundations and larger donors
 - iii. Phase 3—Public donations, smaller amounts to reach goals, sponsor specific items, etc.
- d. SOHFA is working on getting the liquor license to sell beer and wine for shows.
