Tree Commission Meeting Minutes Thursday, April 14th, 2022 @ 5:00 PM Virtual Meeting - Stoughton, WI

Call to order: Tangeman called to order @ 5:03 PM

• Communications:

- *Kemppainen* stated he received a donation from Urban Wood Network for \$1,700.00 for grant work that he did on a project. The grant will be used as we see to be fit.
- Kemppainen stated he sold lumber to Grand Inspired a few times this past month amounting to \$110.00
- *Point* stated that the Arbor Day Art Show set up went well and he was able to check in several times throughout the week for any new possible pieces.
- *Kemppainen* stated that the Kiln was decommissioned and Public Works Department is building a new stationary solar Kiln to be at the Yard waste site.
- Approval of minutes from March 10th, 2022 Meeting: Motion by Point, seconded by Mazzone to approve the minutes. Carried 5-0.
- March Forestry Reports: Kemppainen stated:
 - There was a large storm event on 3/5/22 which resulted in the loss of several trees. A special brush collection event was scheduled because of the storm and 8 days were spent picking up brush. An additional 3-4days were spent on remediation tree work and removals
 - I assisted with snow removal for one storm event in March. Unfortunately, this snow event took place during the cleanup efforts of the wind event on 3/5/22 and slowed the cleanup effort
 - Road construction project planning continued in March. Meetings and phone calls with residents who
 will be impacted by the road projects and subsequent tree removals took up a sizable amount of time.
 - No residents were notified of code violations in March.

• OLD BUSINESS: Update on Tree Planting Sale:

• *Kemppainen* stated he picked up 25 trees from Wheeler Nursery, each priced at \$22/each and stand 4-6 feet in height. He still needs to pick up trees from McKay and there are already 25 trees planted in the gravel bed that could also be sold; which are much bigger. There are a total of 75 trees that will be available for sale. He suspects there should be a large interest in this, this year due to the March storm we endured. Plant sale is April 30th from 9:00am to Noon.

Update on Arbor Day school meeting:

Kemppainen stated the only school that he heard back from was Fox Prairie so he has a time set up with them to go there on Arbor Day and talk with the kids.


- NEW BUSINESS: Discussion of meeting day/time for future meetings:


Motion by Tangeman, seconded by Mazzone to move the meeting to the 2nd Wednesday of every month at 5:00pm. Motion carried 5-0

Re: May Forestry Activities Report

- Spring tree planting planning was completed in May. 90 trees were planted this spring around the city.
- The first Arbor Day Art Show concluded in May. Former tree commission member Kathy Esch spearheaded the effort, which was held at the Stoughton Public Library.
- Five (5) city trees were removed due to poor health and/or storm in May. This work was completed by Jims Tree Service.
- Public Works crews removed twenty seven (27) stumps in April and May from previous removals.
- Five (5) terrace tree planting applications for new construction were submitted in May, all in the Nordic Ridge subdivision.
