Call to order: Tangeman called to order @ 5:03 PM

1) Communications:

Kemppainen stated he has been working on sidewalk repairs with Kevin & the DNR this week due to root issues. New sidewalks should be in next week Kemppainen stated a new member for the commission should be approved for next month by

2) <u>Approval of minutes from May 13th, 2021 Meeting:</u> Motion by Point, seconded by Hundt to approve the minutes. Carried 4-0.

3) May Forestry Reports: Kemppainen stated:

- Spring tree planting was completed. 69 new trees were planted, along with several replacement trees under warranty
- I worked with Brain Wahl from the WIDNR regarding a tree root/sidewalk study that we are partnering on in Stoughton
- The Forestry Intern began work in May. Tyler Drost is a student at UWSP going into his sophomore year this fall. He has already proven to be a hard worker
- The trees for the DNR UF Grant continue to do well in the gravel bed nursery. They are now being watered twice daily due to the heat and dry conditions we are experiencing
- The Lead Service Replacement Project being completed by SU is now ongoing and is beginning to require multiple site visits per week to discuss tree issues.

4) OLD BUSINESS: Discussion on 2021 DNR Grant – Timeline, forms and report on hours:

- Kemppainen stated all trees plated are still alive and asked for suggestions on how to further more get the word out about the free trees available to residents
- Engelberger suggested putting a message on the digital solar traffic sign that is in front of the Fire Department
- Hundt will mention something at the next Council meeting
- Engelberger offered to write a letter to the editor to encourage residents to water their trees as well as more information about the trees available
- Kemppainen will be keeping track of everyone's hours for the Grant now that Bergeson is no longer on the Commission

5) NEW BUSINESS: List for Legacy Tree Program:

• Tangeman stated this list is still a work in progress and hopes to be able to update as time goes on

6) Review Tree Applications:

- *Kemppainen* stated he has received 6 applications so far. The majority of them have stated they would like new trees due to losing trees in the past
- Any leftover/unused trees need to be planted on private property within the City limits; will address where when the time comes

Re: September Forestry Activities Report

- The trees for the DNR Urban Forestry Grant were distributed to residents for planting in September. 38 of the 40 trees survived their time in the gravel bed. Most of the trees were distributed on a single Saturday morning, but several required special pickup times for residents that needed to be scheduled into work days.
- Tree inventory updates continued in September. The area being updated this summer is south of US-51 and east of Page St. This area will be trimmed this coming winter.
- I visited Arthur Weiler Nursery to select trees for the fall tree planting program this year.
 89 trees were purchased for planting throughout the city, the majority of which are being planted in front of new homes and businesses. Significant time was spent on marking locations for the fall planting season.
- The Lead Service Replacement Project being completed by SU is ongoing and continues to require multiple site visits per week to discuss tree issues.
- We were able to setup a demo visit for a new brush chipper in September. Everyone agreed that the Morbark unit that we used would be a good replacement for the existing Morbark chipper that we have currently.
- Several residents were notified of code violations for dead/dying/dangerous trees in September. Furthermore, going forward the Public Works Department will be responsible for notifying residents of these code violations instead of the Planning Department. This will mean more time spent by the Forestry Division on these matters in the future.
